Discrimination Policy

Heartland Welding Academy, LLC in its admissions, instruction, and graduation policies does not discriminate on the basis of race, creed, color, religion, sex, sexual orientation, gender identity, disability, age, marital status, national origin, ethnic origin, Vietnam-era/disabled veteran, or on any other basis prohibited by federal or state law, in its education programs or employment.

Admission Requirements

- Must be at least 17 years of age to enroll and turn 18 by program completion date (proof of identification & age required).
 - Students who are 17 at enrollment are required to have a parent or legal guardian sign the enrollment agreement, as well as a liability waiver.
- Fill out & sign the Enrollment Agreement
- Pay \$100 enrollment fee (*this fee is waived for Veterans*)
- Provide a valid photo ID
- Provide a copy of a High School Diploma, high school transcript, or GED completion document
- Complete the O*NET interest profiler
- Interview with the Managing Director or the Admissions Director
- If applicable, complete all requirements of financial aid or assistance (see below)
- Must have good eyesight or wear corrective lenses. If corrective lenses are needed it is *recommended* to have a vision test no more than six months old.
- Heartland Welding Academy will offer reasonable accommodations for physical limitations if possible. (*see Disabilities Policy pg. 18-19*)

Health Requirements

Students with special health concerns, medical conditions, pre-existing injuries, physical limitations, or pacemakers that may cause physical danger to oneself or others will need to consult with the Director of Admissions before enrolling. It may be required to have a physical examination and medical clearance from a licensed physician prior to admission acceptance. Students are required to wear personal safety equipment for up to 6 hours per day. This includes safety glasses, face shields, ear plugs, thick leather soled work boots.

Pregnancy

If prior to enrolling or while attending a student becomes pregnant, they should notify their physician immediately and disclose the physical demands associated with attending the program. Full disclosure will allow the physician to make an informed decision regarding the student's ability to perform in the field of welding. Accommodations may be granted to those who qualify. Students who do not notify a physician of a change in pregnancy status take full responsibility for any difficulties encountered while enrolled in their program. All costs related to health requirements will be the sole responsibility of the student.

Disabilities Policy

Heartland Welding Academy prohibits discrimination of applicants, students, and employees on the basis of a disability. Applicants or students with disabilities should notify the Director of Admissions of the disability, and to discuss accommodation needs. Disabilities also include unseen disabilities such as learning disabilities, psychological health injuries, and cognitive disabilities. Completion of the Structural Code Welding course will ready each student for weld testing and employment within structural/ fabrication applications. Applicable industries are Power, Petro-Chem, Oil & Gas, Semi-Conductor, Aerospace, and General Manufacturing markets.

- Practical Pipe & Structural Code Welding
 - Course will be a total of 24 weeks
 - 720 HRS

Completion of the Practical Pipe & Structural Code Welding program will ready each student for weld testing and employment within pipe and structural/ fabrication applications. Applicable industries are Power, Petro-Chem, Oil & Gas, Semi-Conductor, Aerospace, and General Manufacturing markets.

Credits

Heartland Welding Academy is based on Clock Hours and does not issue credits.

Credit Transfer

HWA will assess prior welding education/training where credits were earned to determine if those credits are line with our current curriculum and training. Assessments will be made on a case-by-case basis and will require a welding exam.

Training in use and application of the Shielded Metal Arc Welding (SMAW) and Gas Metal Arc Welding GMAW and Flux Cored Arc Welding (FCAW) processes through classroom lecture/discussion and laboratory/shop activities; arc welding safety; welding in the 1F(Flat), 2F/2G (Horizontal), 3F/3G (Vertical) and 4F/4G (Overhead) positions on plate based material to meet or exceed the visual and applicable destructive testing requirements of the latest edition of the American Welding Society D1.1/D1.1M:20XX STRUCTURAL WELDING CODE-STEEL code of construction requirements.

Students will attend class for 6 hours a day, Monday through Friday, for a total of 30 hours of instruction and laboratory time per week.

Students will be provided a mid-term progress report at the program midpoint (180 clock hours). If consistent progress is not present towards the program completion requirements, they will be provided counseling on methods of improvement.

Program Completion Requirements

Successful completion of the program will require:

- 70% cumulative GPA on all textbook written tests
 - Meeting visual standard requirements on all welds
 - Students will complete a pre-determined set amount of each weldment. Those unable to attain visual acceptance criteria will not progress forward in laboratory welding assignments until visual acceptance criteria is met.
 - Pass required destructive testing
 - Students will have the opportunity to perform pre-determined welding qualification testing at specific points of their weld training.
 - Passing of these specific tests will be required in order to receive a certificate of completion for the program.
 - Successfully complete the online OSHA10 training modules
 - Maintain satisfactory attendance as per the predefined policy stated in the Attendance Policy
- Students are required to complete a minimum of **306 clock hours to receive a Completion Certificate.**

Students will attend class for 6 hours a day, Monday through Friday, for a total of 30 hours of instruction and laboratory time per week.

Students will be provided progress reports at the program midpoint (360 clock hours). If consistent progress is not present towards the program completion requirements, they will be provided counseling on methods of improvement.

Program Completion Requirement

Successful completion of the program will require:

- 70% cumulative GPA on all textbook written tests
 - Each student will have the opportunity to retake a failed quiz or course. Any repeated test at a higher grade will replace the failed test.
- Meeting visual standard requirements on all welds
 - Students will complete a pre-determined set amount of each weldment. Those unable to attain visual acceptance criteria will not progress forward in laboratory welding assignments until visual acceptance criteria is met.
- Pass required destructive testing
 - Students will have the opportunity to perform pre-determined welding qualification testing at specific points of their weld training.
 - Passing of these specific tests will be required in order to receive a certificate of completion for the program.

- Successfully complete the online OSHA10 training modules
 - Maintain satisfactory attendance as per the predefined policy stated in the Attendance Policy
- Student must complete a minimum of **612 clock hours to receive a Completion Certificate.**

- Students must meet AWS D1.1 testing standards in the 5G 6010/7018 SMAW process to receive a Completion Certificate
 - If a student fails to meet this requirement, but meets all other requirements they will receive the earned structural welding certifications and a Completion Certificate that states “Partially Completed”

Student Code of Conduct

Heartland Welding Academy is designed around the employer's environment and expectation. Students will be expected to conduct themselves as in a job-like environment. Any behavior that is disruptive or destructive will not be tolerated. HWA has a zero-tolerance policy and student(s) will be dismissed if not compliant.

Dress Code

- Denim long sleeved shirt or a weld jacket is required to be worn when welding.
- Welding hood, safety glasses, and approved welding gloves are required to be worn when welding.
- Leather upper boots with a defined heel are required to be worn at all times (*traditional cowboy boots are not acceptable*).
- Denim jeans are required to be worn at all times.
- No holes allowed
- No loose or exposed threads (i.e., tattered apparel)
- Pants must be worn properly and tight at the waist
- A short-sleeved shirt with a minimum of a 3 inch sleeves, is acceptable if welding jacket is worn at all times

Drug and Alcohol Policy

HWA has a zero-tolerance policy for the violation of the Drug and Alcohol Policy. If at any time a student is in violation of this policy, they will be dismissed.

- The consumption of alcoholic beverages or use of any intoxicating substance prior to class or during class will prohibited, regardless of age.
- If at any time you are suspected to be under the influence, HWA Personnel has the right to remove you from the premises. Student may be subject to termination.
- The possession of drugs, alcohol, or paraphernalia is not allowed on HWA property, including and not limited to personal vehicles. Termination is eminent.
- The purchase, sell, or transmission of illegal or controlled substances is prohibited and punishable by law.
- Any student has the right to inform HWA personnel if aware of any intoxication or substance abuse For-Cause.
- HWA has the right to conduct random drug testing.

Disciplinary Action

Note- the Managing Director has the authority to terminate any student that violates policy in an effort to maintain the safety and environment for others.

1. A Student Warning Write Up Form completed by HWA personnel will be provided to the student. The Write Up will be reviewed with the student, in which the student will be given an opportunity to respond. The Form will be signed by the student and HWA personnel. A copy will be provided to the student and a copy will be placed in the student's file.

2. If the student commits a second violation a second Student Warning Write Up Form will be completed. The student will then be required to meet with Director of Admissions and the Managing Director to discuss the Write Up. A signed copy will be provided to student and a copy will be placed in the student's file. Depending on the magnitude of the violation, student termination may be applicable if advised by the Director of Admissions.
3. If a third offense is committed, a written confirmation of the violation will be documented by the Director of Admissions and a signed copy will be provided to student and a copy placed in the student's file. Termination is absolute.

Attendance Policy

Heartland Welding Academy manages its attendance policy based on an employer/ jobsite expectation. Your value is only as good as your attendance. You are required to be at class on time and every day. Tardy, early out, or any other absence will be recorded in your attendance record. Your instructor will note if you are present when class starts and when class is complete.

Structural Code Welding- You will be allowed **9 unexcused absences** during the term of your program. If you exceed 4 days unexcused, you will be placed on probation and written up. If you continue to exceed these limits you will be subject to dismissal by the Director of Admissions.

Practical Pipe & Structural Code Welding- You will be allowed **18 unexcused absences** during the term of your program. If you exceed 9 days unexcused, you will be placed on probation and written up. If you continue to exceed these limits you will be subject to dismissal by the Director of Admissions.

All tardy, sick, personal day, or any other absence will be documented in your attendance record.

Make up work and time is not guaranteed by HWA. Make up sessions will be based on scheduling and availability.

Unexcused absences will not have make-up time. Excused absences will be allowed make up time on a "scheduled" basis.

Excused absences are as follows with supporting documentation.

- Death of immediate family member
- Court order
- Illness, with proper physician documentation
- Family emergency (to be determined excused by the Director of Admissions)
- Other events in which are approved in advance by the Director of Admissions

Notification of Absence

Students are required to notify the main office if they will be late or absent from class.

Termination due to absence

A student will be considered Withdrawn if they have not attended 5 consecutive days without notifying HWA. A termination notice will be forwarded to the student's address on file. Any refund due shall be refunded within 45 days of the last date of attendance (see Refund Policy).

Late In's (Tardies)

Students are expected to be in class on time every day. Students arriving after the prescribed start time (unless late arrival has been pre approved) will be counted in the attendance as late.

Two "late-ins" will constitute as one unexcused absence. A "late-in" is considered any time after the prescribed start time of class and/or start time of class after a scheduled break.

Early Out's

Students are expected to remain in class for the entirety of their scheduled shift. Students who leave class early (unless the early out is pre-approved) will be counted as an "early out" in the attendance.

Two "early outs" will count as one unexcused absence. An early out is considered anytime a student leaves class prior to the prescribed dismissal time.

Standard Academic Performance (SAP)

Satisfactory Academic Performance (SAP) are the standards (qualitative, quantitative, and incremental) that determines whether or not students are making the satisfactory progress required to complete their program. SAP requirements apply to all HWA students.

When is SAP evaluated

SAP is evaluated based on payment periods. A payment period is defined in clock hours and weeks of instructional time. All programs at HWA have two payment periods. The first payment period begins when a student starts their program, and ends when the student has reached half of the scheduled hours/weeks of instruction time. This is also defined by HWA as the program Midterm. The second payment period begins after the program Midterm and ends when the student has completed their program. See chart below.

	1 st payment period	2 nd payment period
Structural Code Welding	0-180 / 6 weeks	181-360 / 6 weeks
Pipe & Structural Code Welding	0-360 / 12 weeks	361-720 / 12 weeks

Criteria for SAP

Quantitative criteria

Heartland Welding Academy evaluates the student's pace by dividing the cumulative number of hours the student has successfully completed by the cumulative number of hours the student has attempted. A student must have completed 85% or greater to be considered making SAP

- Pipe and Structural Code Welding Example: $720 \text{ hrs} / 2 = 360 \text{ hrs}$ (Midterm point)

85% of scheduled hours per payment period: $360 \text{ hrs} \times 85\% =$ **306 hrs completed to maintain SAP**

- Structural Code Welding Example: $360 \text{ hrs} / 2 = 180 \text{ hrs}$ (Midterm point)

85% of scheduled hours per payment period: $180 \text{ hrs} \times 85\% =$ **153 hrs completed to maintain SAP**

Heartland Welding Academy rounds to the nearest whole number using normal rounding methods

Qualitative Criteria

Heartland Welding Academy has a minimum cumulative letter grade percentage requirement of 70% in classroom quiz/ tests to be considered as meeting SAP.

Heartland Welding Academy evaluates student's progression in the weld lab based on the pace at which they are completing individual skill blocks.

Structural Code Welding Program –at the completion of 180 hours students must have passed the visual inspection of 2G 7018 with backing strip.

Practical Pipe & Structural Code Welding Program –at the completion of 360 hours students must have passed the visual inspection of 4G 6010/7018 weave.

Maximum Time Frame Allowed

For programs measured in clock hours the maximum timeframe allowed for a student to complete cannot be longer than 150% of the published length of the program, as measured by the cumulative number of clock hours the student is required to complete and expressed in calendar time.

Financial Aid Warning

A student is placed on financial aid warning if they fail to meet SAP at the midterm (end of 1st payment period). This could be the result of a cumulative letter grade percentage below the 70% requirement, or from not meeting the 85% attendance requirement. Students are still able to receive financial aid while on financial aid warning.

Notification of SAP results

Students are given a midterm review, that includes SAP evaluation results by their instructor at the end of the first payment period. HWA will conduct this review and notify students of the results within a week of the end of the first payment period.

Incompletes

Heartland Welding Academy does not allow students to receive incompletes. Students who do not meet the Program Completion Requirements as defined in the Student Handbook (pg 7-9) will not be considered as a "Program Completer"

Leave of Absence

The purpose of this policy to confirm that HWA is in compliance with Federal Regulation 34CFR 668.22(d), regarding the process for students requesting A Leave of Absence.

A Leave of Absence (LOA) is a temporary interruption in a student's program of study, and refers to the specific time period when a student is not in attendance. A LOA, together with any additional leaves of absence cannot exceed 180 days in any 12 month period.

LOA Request Requirements:

Students are required to fill out, sign, and date a Leave of Absence Request Form. The request must include:

- Dates of LOA
- Type of Leave – Planned, Unplanned, or Military
- Written explanation of the reason for the request
- Provide additional documentation along with the request that validates the need for of LOA

LOA Request Process:

Students must submit the request & additional documentation to the Admissions Office

The request will be reviewed by the Admissions Office to ensure that it meets the criteria of the Department of Education guidelines 34 CFR 668.22 (d).

The request will then be reviewed and considered by the Managing Director for final approval or denial. HWA will review and grant approval/denial in a timely manner.

In the event that unforeseen circumstances prevent a student from providing a request prior to the LOA (ie Unplanned Leave of Absence) HWA may retroactively grant approval for a LOA if:

- Proper documentation of the unforeseen circumstance is provided, along with completion of the Leave of Absence Request Form.

If during the approved LOA the student seeks to amend the LOA in any way, the student will be required to request the change in writing, along with documentation, to the Managing Director. Amending an approved LOA is at the sole discretion of the Managing Director.

Additional Policy Requirements:

- A LOA cannot be granted for academic reasons (i.e to keep a student from failing their program)
- There must be a reasonable expectation that the student will return from the LOA
- A student returning from a LOA must resume training at the same point in the program that they began the LOA
- HWA may NOT assess any additional institutional charges and therefore the student is NOT eligible for any additional Federal Student Aid (Title IV funds)
- If the student is a Title IV recipient, HWA must provide an explanation to the student, prior to approving the LOA, the effects that the student's failure to return from the LOA may have on the student's loan repayment terms, including the expiration of the student's grace period.
- If a student does NOT resume attendance on or before the end of the LOA, HWA must treat the student as a withdrawal. If the student does not return from the LOA, the withdrawal date will be retroactive to the date of signing the LOA. This may affect the student's grace period for student loan repayment.

Safety Policies and Procedures

On site accident or injury/Medical emergency:

1. Students are to report to instructor immediately.
2. Instructor is to quickly assess the injury to determine if basic first aid is needed, if the student needs to be taken to the emergency room, or if necessary, call 911.
3. All activity will be stopped and all students will need to vacate the immediate area until the situation is resolved.
4. After the injury has been assessed and what action to be taken is determined, the instructor will notify the student's emergency contact on file.

Evacuation:

Any of the following events will require evacuation; fire, smoke, gas leak, explosion, structural damage/collapse, hazardous material spills, odors or fumes.

1. Notify instructor immediately.
2. Calmly move to the nearest/safest exit and proceed out of the parking lot towards the front of the building, muster point will be on the NW side of the building on the city sidewalk (nearest the large green utility boxes)
3. The instructor will ensure that all students have evacuated and will call appropriate emergency personnel.
4. Students and staff should remain together until told they can re-enter the building.

Fire/Explosion:

All fires should be reported to the Andover Fire Department immediately by dialing **911** at the time of the event, even those that can be extinguished.

1. Evacuate the facility immediately utilizing the evacuation procedure posted at the exits and proceeding to the muster point through the safest and quickest means of egress.
2. The lead instructor will sweep the area for any personnel or students left in the building and confine the fire by closing all doors accessible.
3. If it is safely achievable the lead instructor will attempt to extinguish the fire with the nearest fire extinguisher prior to exiting the building.

Threats of violence/Bomb threats/Suspicious packages:

Whoever intercepts the threat should make every effort to collect as much information as possible. This includes taking notes if threat is received via phone, screenshots if received via social media or email.

1. If the threat is a suspicious package do not touch or move it.
2. If any threats of violence or suspicious packages are received HWA staff will notify law enforcement immediately.
3. All staff and students will evacuate the HWA premises quickly and calmly if necessary.
4. Proceed to evacuation point located on the NW side of the building on the city sidewalk (nearest the large green utility boxes).

Neighborhood disturbances/Civil unrest:

If an incident of civil unrest/civil disturbance/rioting is occurring in the immediate area near HWA, faculty will communicate with law enforcement.

-
1. Students will be instructed to avoid the area of disturbance and to avoid provoking the demonstrators.
 2. Everyone will remain inside and all entrances to the facility will be locked.
 3. If notified by law enforcement that it is safe, students and staff will leave the HWA premises through the safest route possible.

Severe Weather:

Winter weather - HWA will make decisions on closures in a timely manner to ensure the safety of all faculty and students.

Thunderstorms - Kansas is prone to severe thunderstorms

- Staff and instructors will monitor weather alerts and warnings.
- If severe weather is expected HWA will cancel or dismiss class if it can be determined that traveling is not safe for staff and students.
- If thunder and lightning are occurring near the facility students will be instructed to remain inside.
- Tornadoes
- If a tornado watch is issued for Butler County or East Sedgwick County instructor will halt all activity and notify students that a watch is in effect.
- If the focused area of the risk is within a 20 mile radius of HWA, students will halt weld related activities and gather in the classroom area until weather threat has subsided.
- If a tornado warning is issued for Butler County, and Andover specifically, is expected to be impacted, students and staff will seek immediate shelter in the central most part of the building which is the Student Break Room.

Student under the influence of drugs/Alcohol:

HWA has a zero-tolerance policy for the violation of the Drug and Alcohol Policy. If at any time a student is in violation of this policy, they will be dismissed.

- The consumption of alcoholic beverages or use of any intoxicating substance prior to class or during class will prohibited regardless of age.
- If at any time you are suspected to be under the influence, HWA Personnel has the right to remove you from the premises. Student may be subject to termination.
- The possession of drugs, alcohol, or paraphernalia is not allowed on HWA property, including and not limited to personal vehicles. Termination is eminent.
- The purchase, sell, or transmission of illegal or controlled substances is prohibited and punishable by law.
- Any student has the right to inform HWA personnel if aware of any intoxication or substance abuse For-Cause.
- HWA has the right to conduct random drug testing.

Active Shooter/Sudden Violence Situations:

Defined as a person/persons who are actively engaged in or seeking to kill and/or injure people. Possible weapons can include firearms, knives, vehicles, etc.

These situations are dynamic and evolve rapidly.

Everyone must be prepared to react quickly.

The best option is to RUN.

- Know escape routes in advance, warn others as you are fleeing and do not waste time gathering your belongings.
- If you encounter police officers while fleeing keep your hands visible, follow their instructions, and move in their direction unless instructed to do otherwise.
- Evacuate to a safe area and take cover until emergency responders arrive.
- If you are unable to escape HIDE.
- Close and lock all doors if possible, turn off lights, silence cell phones, and any other devices that might make noise. Stay out of sight.
- Designate ONE person in the room to quietly call 911.
- Relay the following information to the 911 dispatcher; your name and location, number of people with you, any known injuries, known location of the suspect, physical description of suspect, and types of weapons suspect has.
- Remain in place until police arrive.
- Do not open the door unless you are certain it is the police.
- If confronted by the suspect your only option is to FIGHT FOR YOUR LIFE.
- This means to act aggressively, using physical force to render the suspect unable to continue.
- If possible, work together with others.

Visitor

- All visitors will follow posted signage and wear the appropriate personal protective equipment in marked areas. Visitors will stay inside marked pathways, unless escorted by a school employee.
- If in the case of an emergency or evacuation, all visitors will follow a school employee's direction accordingly.

Procedure for reporting and Investigating health and safety incidents

- A Health and Safety Incident Report Form should be filled out by an HWA staff member as soon as possible.
 - This form includes date, time, location of incident, type of incident, incident summary, response summary, and recommended corrective/preventative action.
 - This form is submitted to the Managing Director, who will determine if the incident requires further action or if the incident is considered resolved
 - The form will be permanently filed

Student Guidance/Counseling

HWA instructors and the Director of Admissions are available by appointment to discuss issues directly related to HWA such as student progress, the curriculum, attendance, leave of absence, financial guidance as it applies to HWA, conflict/complaint/grievance, and placement. It is the goal of everyone employed at HWA to help students in any area that we are knowledgeable and qualified. Should a student seek counseling/advisement that HWA staff is not qualified to assist in, every effort will be made to guide that student to the correct outlet.

Media Services

Heartland Welding Academy supplies students with all media services needed while enrolled. The following are the media materials supplied to each student; HWA Welding Curriculum, Pipe Fitters Blue Book, various handouts, OSHA10 log in code (via American Safety Council or Career Safe) and teleconference account and log in (if needed for virtual class). Internet access and computer use is also available to students if needed. WiFi internet access is available in the Main Office and Classroom areas. Computers are available for students to use. Usage is during office hours Monday-Friday and can be scheduled with the Director of Admissions.

Employment Placement

Heartland Welding Academy DOES NOT guarantee placement or salary expectations. It is our intent to ready students to the best ability fundamentally and professionally throughout the course(s). HWA conducts the following to assist all students with employment placement; maintaining regular contact with employers, maintaining a database of potential employers, posting job opportunities, along with several elements that are taught in the Professional Development portion of the HWA student textbook.

The required professional development course rounds off each student's personal presentation and addresses needs of "today's" jobsites, in advance of the employer. Career development over time can include journeyman, project management, technical and/or product specialist, or sales representative to name a few.

Brush Up Policy

Any student who successfully completed their program, does not have a balance on their account, and is in good standing is allowed the opportunity for brush up time.

Brush up must be scheduled in advance and is based on availability

There is a 2-day maximum per instance

Brush up is only allowed on processes that the student successfully completed while they were enrolled

Student will provide their own safety equipment. If a specialty material (that is not commonly kept in stock) is needed student must provide

Student Records

Students will receive a copy of their Completion Certificate, all AWS D1.1 Welding Certifications, an Exit Review, and their official transcript in person from an HWA official. If the student cannot be present for reception of certificates, they will be mailed to address on record. Students who have a balance on their account will not receive any completion paperwork until their account is paid in full.

Any documents containing student's personal information, are accessible only to HWA Administration and cannot be duplicated for any reason. Students may request to view their records through the Director of Admissions.

Completion documents such as official transcripts and welding certifications can be requested in writing to the Director of Admissions. Hard copies can be mailed or picked up in person by the student. Records containing personal information will not be faxed or emailed.

Consumer Info

Family Educational Rights and Privacy Act (FERPA)

The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99) is a Federal Law that protects the privacy of student education records. The law applies to all schools that receive funds under an applicable program of the U.S. Department of Education. FERPA sets limits on the disclosure of personally identifiable information from school records and defines the rights of students to review school records and request changes.

Right to Review: HWA ensures that students have the right to review their educational records. Students who desire access to their educational records must make a request in writing with Student Services by filling out a Request for Information Form.

Consent for Disclosure: Students have the right to provide consent for the disclosure of their records. Parents, guardians, or other designated individuals are only permitted access to a student's records with prior written consent from the eligible student. A student must provide signed and dated written consent before the school may disclose personally identifiable information (PII) or education records.

This consent is required to include the records that may be disclosed, the purpose of the disclosure, and identify the party (or parties) to whom the disclosure may be made. HWA is required to provide the student with a copy of the records that have been disclosed, if requested. HWA maintains a listing in the student's file to whom personally identifiable information was disclosed and the legitimate interests of the parties had in obtaining the information.

Request Amendments: HWA ensures that students are allowed to request amendments of information within their educational records on the grounds that the records are inaccurate, misleading, or violate the rights of the student. A request for an amendment of educational records can be made by following the published Grievance Policy.

Disclosure Without Consent: Under provisions of the act (34CFR 99.31) there are certain conditions where the school is permitted to disclose PII and education records without consent from the student.

HWA is permitted to give access to student education records to the following parties without consent from the student:

- Specified school officials whom have legitimate educational interest. These school officials include persons employed by HWA in an administrative, supervisory, academic, or support staff position.
- Persons serving on the board or advisory committees
- Contractors who perform service functions and who are under direct control of the school with respect to the use and maintenance of personal identifiable information; such as an attorney, auditor, or collection agent.
- U.S Comptroller General, U.S Attorney General, U.S Department of Education
- State & local officials
- Authorized organizations conducting educational research
- Accrediting Agencies
- Alleged victim of a crime
- Parent of a Dependent Student as defined by the IRS

-
- Officials at another school in which a student is seeking to or intends to enroll
 - Parent of a student under the age of 21 regarding the violation of law regarding drug or alcohol abuse

Additional exceptions:

- Court order or lawfully issued subpoena

HWA is required to make a reasonable effort to notify a student who is the subject of a subpoena or court order before complying, so that the student may seek protective action (unless the court or issuing agency has prohibited such disclosure).

- Health & Safety exception

HWA is permitted to disclose personal identifiable information from a student's record in case of an immediate threat to the health & safety of students or other individuals. HWA may only disclose personally identifiable information from an education record to appropriate parties in connection with an emergency IF knowledge of the information is necessary to protect the health or safety of the student or other individuals.

- Information that HWA has determined to be "directory information"

This information includes name address, telephone number, date/place of birth, and dates of attendance, program enrolled in, enrollment status, & most recently attended educational institution.

HWA must notify students about directory information and allow the student a reasonable amount of time to request that directory information about them not be disclosed.

Annual Policy Notification: HWA is required to notify students annually of their rights under FERPA. This notices includes the following student rights; review of records, request changes to records, disclosure consent process, and complaint process. HWA notifies students via the Student Handbook/Catalog and as part of the Student Orientation Process.

Complaint Process: Students have the right to file a complaint with the U.S Department of Education in regards to HWA's failure to comply with the requirements of FERPA. Complaints made be sent to:

Copyright Infringement

As part of the Higher Education Act, HWA is required to readily make available to prospective and current students, policies and sanctions related to copyright infringement. The policy is included in the Student Handbook, the institutions website, and included in the annual Consumer Information Disclosure.

For the purpose of this policy copyright infringement is defined As a general matter, when a copyrighted work is reproduced, distributed, performed, publicly displayed, or made into a derivative work without the permission of the copyright owner.

Unauthorized distribution of copyrighted material, including peer to peer file sharing, may subject students to civil and criminal liabilities. (see summary below)

Copyright infringement is the act of exercising, without permission or legal authority, one or more of the exclusive rights granted to the copyright owner under section 106 of the Copyright Act (Title 17 of the United States Code). These rights include the right to reproduce or distribute a copyrighted work. In the file-sharing context, downloading or uploading substantial parts of a copyrighted work without authority constitutes an infringement.

Penalties for copyright infringement include civil and criminal penalties. In general, anyone found liable for civil copyright infringement may be ordered to pay either actual damages or “statutory” damages affixed at not less than \$750 and not more than \$30,000 per work infringed. For “willful” infringement, a court may award up to \$150,000 per work infringed. A court can, in its discretion, also assess costs and attorneys’ fees. For details, see Title 17, United States Code, Sections 504, 505.

Willful copyright infringement can also result in criminal penalties, including imprisonment of up to five years and fines of up to \$250,000 per offense. For more information, please see the website of the U.S. Copyright Office at <https://copyright.gov>

Drug & Alcohol Prevention

As required by the Drug Free Schools and Communities Act Amendments of 1989 (Public Law 101.226. Sec. 22) This policy states HWA’s standards of conduct related to drugs and alcohol, a description of the legal sanctions (local, state, and federal) for the unlawful possession or distribution of illicit drugs and alcohol, a description of associated health risks from drug & alcohol abuse, and available counseling and treatment programs available. Heartland Welding Academy is required to evaluate this policy biennially to determine its effectiveness, determine the number of drug and alcohol related violations, the number and type of sanctions imposed, and to ensure that the sanctions are consistently enforced.

Heartland Welding Academy is a drug and alcohol-free facility and there is zero-tolerance for the violation of the Drug and Alcohol Policy. Students and HWA personnel who are found to be in violation of this policy are subject to termination as well as legal sanctions as imposed by local, state, and federal law.

Per this policy the following conduct is strictly prohibited:

- Attending class while under the influence of, or impaired by illicit drugs or alcohol
- Public intoxication on HWA property
- The use, possession, manufacture, purchase, sale, or furnishing of illicit drugs, narcotics, or other controlled substances; including marijuana
- The use, possession, manufacture, purchase, sale, or furnishing of alcohol
- Drug paraphernalia on HWA property, including and not limited to personal vehicles, lockers, etc.
- Operating or attempting to operate a vehicle while intoxicated
- Possession or consumption of alcohol by persons under the age of 21
- Furnishing, dispensing, and/or providing alcohol to persons under the age of 21

Any student has the right to inform HWA personnel if aware of any intoxication or substance abuse For-Cause.

Drug Testing

HWA has the right to conduct random drug testing. This applies to HWA staff, current students, and students in the admissions process. Drug testing may be conducted at any time and for any reason deemed necessary by HWA staff or administration.

Federal Law

Penalties for violations of drug and alcohol under federal law for unlawful possession of a controlled substance in violation of 21 U.S.C. §844(a), include:

First Conviction: term of imprisonment of not more than 1 year, a minimum fine of \$1,000, or both.

Second Conviction: At least 15 days in prison but not more than 2 years, minimum fine of \$2,500 but not more than \$250,000 for an individual, or both.

After two convictions: At least 90 days in prison but not more than 3 years, minimum fine of \$5,000 but not more than \$250,000 for an individual, or both.

For more information about maximum penalties for violation of the Federal Controlled Substances Act and Related Laws, see <http://www.fas.org/sgp/crs/misc/RL30722.pdf>

Unlawful distribution of a controlled substance to an individual without that individual's knowledge with the intent to commit a crime of violence, including rape is punishable by up to 20 years of imprisonment; a maximum fine of \$250,000. 21 U.S.C. §841(b)(7).

Unlawful distribution of a controlled substance, possession with intent to distribute, or manufacturing a controlled substance in, on or within 1000 feet of a public college or university is punishable by not less than 1 year of imprisonment and twice the maximum penalty provided by law. For second convictions, the mandatory minimum term of imprisonment is 3 years and three times the maximum punishment provided by law. 21 U.S.C. §860.

Penalties for drug traffickers and possessors also include loss of federal benefits, including student loans and federal financial assistance, and civil penalties up to \$10,000 for each violation. 21 U.S.C. §862 and 21 U.S.C. §844a(a).

Kansas Law

Penalties under Kansas law for the unlawful possession or distribution of drugs are based on the quantity of drug, type of drug, and criminal history of the defendant. See K.S.A. 2012 Supp. 21-5706. Maximum penalties range from fines of \$100,000 to \$500,000 and imprisonment from 10 months to 17 years.

Alcohol-related penalties under State law

It is illegal under Kansas law and local ordinance for a person of any age to consume alcoholic liquor on public property except when permitted by Kansas Board of Regents and University policy. A violation of this state law is punishable by a fine of not less than \$50 nor more than \$200, imprisonment for not more than 6 months, or both.

It is illegal under Kansas law and local ordinances for persons under 21 years of age to possess, consume, obtain, purchase or attempt to obtain alcoholic liquor or cereal malt beverages. Maximum penalties include a fine up to \$500 dollars (a mandatory minimum fine of \$200 for persons 18 and 21 years of age); completion of 40 hours of public service; completion of a community-based alcohol and drug educational or training program with costs assessed to the offender; and mandatory suspension of driving privileges for 30 days for a first conviction; 90 days for a second conviction; and 1 year for a third or subsequent conviction.

Convictions for Driving Under the Influence (DUI) include a mandatory alcohol and drug evaluation and requirement to following any recommendation made as a result of that evaluation with costs assessed to the defendant, and additional penalties, including:

First Conviction

- A fine of not less than \$750 nor more than \$ 1,000, and
- Imprisonment of not less than 2 days nor more than 6 months.
- Mandatory minimum 48 consecutive hours in imprisonment
- Driving privileges suspended for 30 days, followed by a 180-day ignition interlock restriction

Second Conviction

- A fine of not less than \$1,250 nor more than \$1,750
- Imprisonment of not less than 90 days nor more than 1 year
- Mandatory minimum 120 hours imprisonment
- Driving privileges suspended for one year, followed by a 1 year ignition interlock restriction

Third Conviction

- A fine of not less than \$1,750 nor more than \$2,500
- Imprisonment of not less than 90 days nor more than 1 year
- Mandatory minimum 90 days imprisonment
- Driving privileges suspended for 1 year, followed by a 2 year ignition interlock restriction

Fourth Conviction

- A fine of not less than \$2,500
- Imprisonment of not less than 90 days nor more than 1 year
- Mandatory minimum 90 days of imprisonment
- Driving privileges suspended for 1 year, followed by a 3 year ignition interlock restriction (For a fifth conviction, driving privileges are suspended for 1 year, followed by a 10 year ignition interlock restriction)

Refusal to take a preliminary breath test is a traffic infraction usually resulting in a fine. Refusal to take the breath, blood or urine test offered at the police station for a first offense will result in suspension of driving privileges for one year, and two years required use of an ignition interlock device.

City of Andover controlled substance ordinances (per City Code Chapter 13, Article 4)

Except as authorized by State law, it shall be unlawful within the City for any person to:

- (a) Manufacture any controlled substance or controlled substance analog in violation of K.S.A. 21- 5703;
- (b) Cultivate, distribute, or possess any controlled substance or controlled substance analog in violation of K.S.A. 21-5705;
- (c) Possess any controlled substance or controlled substance analog in violation of K.S.A. 21-5706;
- (d) Obtain a prescription-only drug in violation of K.S.A. 21-5708;
- (e) Abuse toxic vapors in violation of K.S.A. 21-5712;
- (f) Distribute, possess, or manufacture any simulated controlled substance in violation of K.S.A. 21-5713;
- (g) Distribute or possess any substance that is not a controlled substance in violation of K.S.A. 21-5714; or
- (h) Receive or acquire proceeds or engage in transactions involving proceeds known to be derived from prohibited activities hereunder in violation of K.S.A. 21-5716.

13-403. Drug Precursors and Paraphernalia; Penalties.

- (a) Except as authorized by State law, it shall be unlawful within the City for any person to:
- (1) Use or possess those substances set forth in K.S.A. 21-5709(a), (c), and (d) in violation thereof;
 - (2) Use or possess any drug paraphernalia in violation of K.S.A. 21-5709(b).

(b) In determining whether an object is drug paraphernalia, a court or other authority shall consider, in addition to all other logically relevant factors, those factors set forth in K.S.A. 21-5711.

13-404. Penalties.

Any person who violates Section 13-402 or 13-403 shall be guilty of a Class A misdemeanor. Upon conviction of a violation of Section 13-402 or 13-403, all costs or expenses of any chemical tests of or for a controlled substance together with the costs or expenses associated with the introduction of evidence concerning such testing shall be payable by the defendant as court costs.

Health Risks associate with Drug and Alcohol Abuse

Alcohol: The consumption of alcohol poses several health risks including impaired judgment, impaired coordination, and impaired attention which may lead to difficulty in safely navigating one's environment or difficulty in safely operating a motor vehicle.

Consuming alcohol may alter a person's ability to learn or retain information, or negatively impact academic, occupational, or social functioning. At low doses, alcohol causes disinhibition and mood lability, increasing risk of inappropriate sexual acts or aggressive behavior. Alcohol depresses the central nervous system and at high doses can cause respiratory depression and death. Repeated use of alcohol can lead to a maladaptive usage pattern referred to as alcohol dependence.

Alcohol dependence is marked by increased physiological tolerance of alcohol's effects and alcohol withdrawal upon sudden cessation of use. Alcohol withdrawal symptoms include autonomic hyperactivity such as anxiety, sweating, and tachycardia; tremors, nausea, vomiting, hallucinations, psychomotor agitation, seizures, and death. Long-term use of alcohol can cause permanent damage to vital organs, particularly to the brain and the liver.

Controlled Substances Uses and Effects

Narcotics

- Possible effects: euphoria, drowsiness, depression of respiratory system, GI upset, constricted pupils
- Effects of overdose: Slow shallow respirations, clammy skin, convulsions, coma, and possible death.
- Drugs: Opium, Morphine, Codeine, Heroin, Methadone, Meperidine, Hydromorphone

Depressants

- Possible effects: slurred speech, disorientation, drunken behavior with or without alcohol odor.
- Overdose: Depressed respiratory system, clammy skin, pupils dilated, rapid weak pulse, coma, and possible death
- Drugs: Chloral hydrate, Barbiturates, Benzodiazepines, Quaaludes.

Stimulants

- Possible effects: Increased alertness, inability to sleep, decreased appetite, euphoria, rapid pulse rate and increased blood pressure
- Overdose: Agitation, increase in body temperature, hallucinations, convulsions, possible death
- Drugs: Cocaine, Amphetamines, Phenmetrazine, Methylphenidate

Hallucinogens

- Possible Effects: Poor perception to time and distance, illusions and hallucinations
- Overdose: Longer more intense episodes of euphoria, psychosis, possible death
- Drugs: LSD, Mescaline , Peyote, PCP, Amphetamine variants

Cannabis

- Possible effects: Euphoria, disorientation, increased appetite, relaxed inhibitions
- Overdose: Fatigue, paranoia, possible psychosis
- Drugs: Marijuana, Hashish, Hashish oil

Loss of Financial Aid Eligibility for drug-related offenses

A student who is convicted of any offense under any Federal or State law involving the possession or sale of a controlled substance for conduct that occurred during a period of enrollment for which the student was receiving any grant, loan, or work assistance under this subchapter shall not be eligible to receive any grant, loan, or work assistance under this subchapter from the date of that conviction for the period of time specified in the following table:

If convicted of an offense involving:

The possession of a controlled substance:	Ineligibility period is:
First Offense	1 year
Second Offense	2 years
Third Offense	Indefinite
The sale of a controlled substance:	Ineligibility period is:
First Offense	2 years
Second Offense	Indefinite

Process to regain eligibility

A student whose eligibility has been suspended under paragraph (1) may resume eligibility before the end of the ineligibility period determined under such paragraph if—

(A)the student satisfactorily completes a drug rehabilitation program that—

(i)complies with such criteria as the Secretary shall prescribe in regulations for purposes of this paragraph; and

(ii)includes two unannounced drug tests;

(B)the student successfully passes two unannounced drug tests conducted by a drug rehabilitation program that complies with such criteria as the Secretary shall prescribe in regulations for purposes of subparagraph (A)(i); or

(C)the conviction is reversed, set aside, or otherwise rendered nugatory.

Treatment and Rehabilitation

Title IX

Enacted in 1972, Title IX prohibits discrimination on the basis of sex in education programs and activities that receive Federal Financial Assistance. “No person in the United States shall, on the basis of sex, be excluded from participation in, denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal Financial Assistance.” (20 U.S.C 1681)

Heartland Welding Academy believes that all students and/or staff have the right to learn/work in an environment that prohibits inappropriate conduct or harassment of a sexual nature. All students and staff have the right to learn/work in an environment free of sexual harassment. HWA prohibits crimes of dating violence, domestic violence, sexual assault and stalking as defined below by Kansas state law.

Definitions:

This policy requires HWA to provide the below definitions as stated by Kansas law.

Domestic Violence (domestic battery) – Knowingly or recklessly causing bodily harm by a family or household member against a family or household member; or knowingly causing physical contact with a family or household member by a family or household member when done in a rude, insulting or angry manner

Dating violence - Knowingly or recklessly causing bodily harm to a person with whom the offender is involved or has been involved in a dating relationship or a family or household member; or knowingly causing physical contact with a person with whom the offender is involved or has been involved in a dating relationship or a family or household member, when done in a rude, insulting or angry manner. (21-5414)

Stalking - "an intentional harassment of another person that places the other person in reasonable fear for that person's safety. (Protection from Stalking Act Article 31A)

Sexual harassment - "Harassment" means a knowing and intentional course of conduct directed at a specific person that seriously alarms, annoys, torments or terrorizes the person, and that serves no legitimate purpose.

Sexual harassment may include any of the following:

- Any instance of quid pro quo harassment by a school's employee;
- Any unwelcome conduct that a reasonable person would find so severe, pervasive, and objectively offensive that it denies a person equal educational access;
- Any instance of sexual assault, dating violence, domestic violence, sexual harassment, or stalking as defined in the Violence Against Women Act

Sexual assault - A nonconsensual sexual act; or

an attempted sexual act against another by force, threat of force, duress or when the person is incapable of giving consent.

Rape - Knowingly engaging in sexual intercourse with a victim who does not consent to the sexual intercourse under any of the following circumstances:

- (A) When the victim is overcome by force or fear; or
- (B) when the victim is unconscious or physically powerless;

Knowingly engaging in sexual intercourse with a victim when the victim is incapable of giving consent because of mental deficiency or disease, or when the victim is incapable of giving consent because of the effect of any alcoholic liquor, narcotic, drug or other substance, which condition was known by the offender or was reasonably apparent to the offender;

- sexual intercourse with a child who is under 14 years of age;
- sexual intercourse with a victim when the victim's consent was obtained through a knowing misrepresentation made by the offender that the sexual intercourse was a medically or therapeutically necessary procedure; or
- sexual intercourse with a victim when the victim's consent was obtained through a knowing misrepresentation made by the offender that the sexual intercourse was a legally required procedure within the scope of the offender's authority.

Consent - the legal age of consent in the state of Kansas is 16. Individuals age 15 or younger are not legally able to consent to sexual activity, therefore such activity would be considered statutory rape.

Sexual battery- (a) Sexual battery is the touching of a victim who is 16 or more years of age and who does not consent thereto, with the intent to arouse or satisfy the sexual desires of the offender or another.

(b) Aggravated sexual battery is sexual battery, as defined in subsection (a), under any of the following circumstances:

- When the victim is overcome by force or fear;
- When the victim is unconscious or physically powerless; or
- When the victim is incapable of giving consent because of mental deficiency or disease, or when the victim is incapable of giving consent because of the effect of any alcoholic liquor, narcotic, drug or other substance, which condition was known by, or was reasonably apparent to, the offender.

Sexual battery is a class A person misdemeanor.

Aggravated sexual battery is a severity level 5, person felony.

(d) Except as provided in subsection (b)(3), it shall not be a defense that the offender did not know or have reason to know that the victim did not consent to the battery, that the victim was overcome by force or fear, or that the victim was unconscious or physically powerless. (21-5505)

Prevention and Awareness Campaigns:

Students are made aware of their rights under Title IX as well as information on dating violence, domestic violence, sexual assault and stalking during their new student orientation.

Awareness programs include bystander intervention, primary prevention, and risk reduction.

Faculty and staff undergo Title IX training as part of their annual Professional Development

Procedure:

Disciplinary action in cases of alleged dating violence, domestic violence, sexual assault, or stalking.

Reporting – Any person who believes they have been a victim of sexual harassment by a student, staff member, or a guest should immediately file a Grievance Report with the Title IX coordinator. This reporting will remain confidential. If the Title IX coordinator deems that further investigation of the complaint is needed, and a criminal report needs to be filed by the victim the Managing Director will also be notified.

Investigation - To determine whether the alleged conduct is sexual harassment the nature of the sexual advances and the context in which they occurred will be considered. The incident will be fully documented (including date, time, witnesses, and a clear statement of what happened).

Action - Students, faculty, staff, or guests of HWA that engage in sexual harassment is subject to immediate discipline including termination. After the investigation has concluded the complainant and the perpetrator will be provided with the results. Any investigation that is found to have merit will be turned in to the Andover Police Department.

Retaliation – against an individual who has made a formal complaint of sexual harassment is strictly prohibited and will result in termination

False Claims – false claims of sexual harassment can also result in disciplinary actions

NOTE: A Covered Individual is any individual who is entitled to educational assistance under chapter 31, Vocational Rehabilitation and Employment, or chapter 33, Post-9/11 GI Bill® benefits. (GI Bill® is a registered trademark of the U.S. Department of Veterans Affairs (VA). More information about education benefits offered by VA is available at the official U.S. government Web site at <https://www.benefits.va.gov/gibill>.)

Heartland Welding Academy permits any covered individual (as defined above) to attend or participate in the course of education during the period beginning on the date on which the individual provides to the educational institution a certificate of eligibility for entitlement to educational assistance under chapter 31 or 33 (a "certificate of eligibility" can also include a "Statement of Benefits" obtained from the Department of Veterans Affairs (VA) website – eBenefits, or a VAF 28-1905 form for chapter 31 authorization purposes) and ending on the earlier of the following dates:

1. The date on which payment from VA is made to the institution.
 2. 90 days after the date the institution certified tuition and fees following the receipt of the certificate of eligibility.
- Heartland Welding Academy will not impose any penalty, including the assessment of late fees, the denial of access to classes, libraries, or other institutional facilities, or the requirement that a covered individual borrow additional funds, on any covered individual because of the individual's inability to meet his or her financial obligations to the institution due to the delayed disbursement funding from VA under chapter 31 or 33.

In addition, statute allows Heartland Welding Academy to require the covered individual to take the following additional actions:

1. Submit a certificate of eligibility for entitlement to educational assistance no later than the first day of a course of education.
2. Submit a written request to use such entitlement.
3. Provide additional information necessary to the proper certification of enrollment by the educational institution.
4. Heartland Welding Academy may also require additional payment or impose a fee for the amount that is the difference between the amount of the student's financial obligation and the amount of the VA education benefit disbursement.

Entrance/Exit Counseling

Students who are eligible to receive Federal Aid are required to complete **Entrance** Counseling prior to the release of any funds. Entrance Counseling is completed online at <https://studentaid.gov/entrance-counseling/>

Students receiving Federal Financial Aid are required to complete **Exit** Counseling at program completion. Exit counseling can be completed at <https://studentaid.gov/exit-counseling/> . Students will not receive their graduation documents & certifications until Exit counseling has been completed.

Enrollment Cancellation Policy

Student enrollment may be cancelled in writing prior to the first day of class. The \$100 enrollment fee is not refundable. All advance tuition payments will be refunded based on the Refund Policy within 45 days of cancellation. All tuition and fees will be refunded if enrollment is rejected by HWA.

If student does not begin classes on date scheduled at time of enrollment, their enrollment will be cancelled, and the \$100 enrollment fee will be retained. Student will be required to re-enroll (fill out another Enrollment Agreement & pay the \$100 enrollment fee) if they seek to attend HWA at a later date.

Program Postponement by the Institution

Postponement of the scheduled start date can be affected by unforeseen safety concerns such as natural disasters, disease outbreaks, or damage to the facility due to accident or disaster. If an agreed upon start date cannot be solidified within a reasonable window of time (up to 45 days) due to such issues, a full refund will apply.

Re-Enrollment Policy

A student who previously withdrew can request to re-enroll. Previous performance, attendance, and behavior will be evaluated by HWA instructors and Managing Director, and re-enrollment is subject to HWA approval. Students who were terminated by HWA are not eligible to re-enroll. Students who have unpaid tuition balances will not be eligible to re-enroll until prior balance is paid in full.

If approved for re-enrollment, students will be assessed on where they were at in the skill block progression when they withdrew. Welding ability in that skill block will be evaluated by an instructor to determine if the student will need to re-complete any skill blocks.

If a student has been withdraw from HWA for 12 months or longer, they will have to start the program from the beginning

Program Withdraw

If a student wishes to withdraw their enrollment after they have started a program a Request to Withdraw form will need to be filled out and submitted to the Director of Admissions. Once submitted the Director of Admissions will determine the official withdrawal date and if a tuition refund applies. *See Refund Policy*

Transfer of Programs within the Institution

Students can transfer from one program to another within Heartland Welding Academy, based on availability and approval from the Director of Admissions. A Request to Transfer Form can be obtained from the Director of Admissions.

If requesting to transfer from the 360 hour program to the 720 hour program student must be meeting the attendance and GPA requirements of the institution. The difference in tuition cost must be paid in advance. If student is financing the tuition cost, all approvals and processes must be completed by completion of 360 hours. A Request to Transfer form must be filled out and submitted prior to completing 240 hours (or 8 weeks)

If requesting to transfer from the 720 hour program to the 360 hour program student must fill out a Request to Transfer Form prior to completing 120 hours (or 4 weeks). Due to the how the classroom portion of the program operates a student wishing to transfer to the 360 hour program will have to wait until the next start date for that program.

Delinquent Payment

Structural Code Welding Program: If paying direct, full payment must be made on or before the first day of class. Failure to pay will be cause for termination. If HWA cannot collect payment, any and all debts could be referred to collections.

Practical Pipe & Structural Code Welding Program: If paying direct, the first payment must be made on or before the first day class. The second payment must be made on or before student has reached their midterm point (360 hours). Failure to pay will be cause for termination. If HWA cannot collect payment, any and all debts could be referred to collections.

Payments from Other Payors

Students receiving funds from other payors; including financial lenders, grants, scholarships, etc must have finalized the required application and approval processes by the first day of class. Documentation of the approved funds must be provided to Director of Admissions prior to the first day of class.

Returned Check (Non-Sufficient Funds) Fee

If a payment made by check is returned, HWA will charge the student a \$35.00 NSF fee.

Institutional Refund Policy

Refund prior to Classes Commencing

Program cancelled by the institution

- If tuition and fees are collected in advance of the program start date and Heartland Welding Academy cancels the class 100% of the tuition and fees collected will be refunded within 45 days of the notice of cancellation.

Student withdraws on or before the first day of the program

- If tuition and fees are collected in advance of the program start date and student does not begin classes or withdraws on the first day of class, the \$100 enrollment fee will be retained and all other payments will be refunded. Any money due shall be refunded within 45 days of the class start date.

Enrollment prior to visiting the institution

- Students who have not visited the HWA facility prior to enrollment will have the ability to withdraw without penalty within **three days** of attending a scheduled student orientation or a tour of the facility and inspection of the equipment.

All tuition and fees will be refunded if enrollment is rejected by Heartland Welding Academy.

If student is receiving funds from a third party payor and withdraws enrollment, HWA will notify payor to cancel distribution of funds and/or issue a refund if needed.

Refund After Class Commencing

HWA will retain the \$100 enrollment fee.

Student will not be refunded for the cost of their tool kit, and the student will keep the kit

Refunds of all other tuition and materials fees are based on the following:

- A student who has completed **50 percent or less of the program**, shall be eligible for a pro rata refund. The completion percentage shall be based on the total number of weeks in the course and the total number of weeks completed.
- After a student has attended **50 percent or more of the program**, the institution shall retain all of the tuition and materials fees. No refund is owed to the student.

Any refund due to a student shall be refunded within 45 days from the last day of attendance or the date the institution terminates the student, or the date the institution determines the student withdrawn.

- In determining the official termination date and percentage of each course completed, the institution may consider the week during which the student last attended to be an entire week of attendance completed.

All refunds, when due, are made without requiring a request from the student.

If student is receiving funds from a third-party payor, HWA will notify payor to cancel distribution of future funds and/or issue a refund if needed.

Termination of Student by the Institution

If a student is considered withdrawn and/or terminated due to non-compliance with any institutions policies, the same refund policy as described above will apply. Any fund providing agencies will be notified by HWA Director of Admissions that the student has been terminated. Any future scheduled funds will be cancelled, and if owed, a refund will be made to the payor.

Return to Title IV (R2T4)

Heartland Welding Academy is required by the Department of Education to provide students with all refund policies applicable at the institution as well as information on the Title IV requirements for determining the amount of Title IV funds a student has earned when they withdraw.

Title IV funds are awarded to a student under the assumption that the student will attend school for the entire period for which the assistance is awarded. If a student withdraws, they may no longer be eligible for the full amount of Title IV funds that they were initially awarded.

A. Payment Periods

Listed below are the payment periods in which students are disbursed Title IV funds. The disbursement is made at the beginning of each pay period. If the student withdraws, a Return of Title IV funds may be required. Transfer students payment periods will vary.

B. Withdrawal from the School

When a student officially or unofficially withdraws from their course of study and a withdrawal date and determination date have been determined, a refund calculation (R2T4) is performed.

C. Determination Date

The date of determination is defined as the date that the school determines when the student dropped. In the event student misses 14 consecutive days of school, a refund calculation (R2T4) will be performed on the 14th day. The withdrawal date will be the students' last day of physical attendance and the 14th day missed will be the date determined.

In the event a student does not return from a Leave of Absence on the scheduled date or if the student notifies the school that they will not be returning from Leave of Absence, a refund calculation (R2T4) will be performed on the earlier of the two dates. The withdrawal date will be the students' last day of physical attendance and either the scheduled return date or the date the student notifies the school they will not be returning, whichever date is earlier, will be the date determined.

D. Official Withdrawal

When a student officially withdraws from their program, the date determined will be the date that the student notifies Heartland Welding Academy. In the event we receive notification of termination via the U.S. Postal Service, the postmark date will serve as the date of determination.

E. Unofficial Withdrawal

If a student does not officially withdraw, Heartland Welding Academy will determine a withdrawal date and determination date and proceed with the Return to Title IV (R2T4) calculations set forth by the Department of Education. All refunds due to the Dept. of Education will be returned within 45 days from the date of determination of withdrawal. Unofficial withdrawals are determined through monitoring attendance at least every fourteen days.

F. Return of Unearned Title IV Funds

If a Title IV financial aid recipient withdraws from their program after beginning attendance, but prior to course completion, a calculation for return of Title IV funds will be completed based on the guidelines set out by the Department of Education and any applicable returns by Heartland Welding Academy shall be paid. Unearned funds must be returned to the Department of Education within 45 days from the date Heartland Welding Academy determined that the student withdrew.

The order in which Title IV funds are returned are as follows:

- a. Federal Direct Loan Program Unsubsidized
- b. Federal Direct Loan Program Subsidized
- c. Federal Direct Loan Program PLUS
- d. Federal Pell Grant
- e. Iraq and Afghanistan Service Grant
- f. Federal, State, private or institutional student financial aid programs
- g. Student

After all applicable returns to Title IV aid have been made, this refund policy will apply to determine the amount earned by Heartland Welding Academy and owed by the student. If the student has received personal payments of Title IV aid, he/she may be required to refund the aid to the applicable program. If the amount disbursed to the student is less than the amount the student earned and is eligible for, the student is eligible to receive a post-withdrawal disbursement of the earned aid that was not received. Any refunds due to the student will be made within 14 days.

When a student withdraws during a period, a Title IV credit balance created during the period is handled as follows:

1. Heartland Welding Academy will not release any portion of a Title IV credit balance to the student and will not return any portion to the Title IV programs prior to performing an R2T4 calculation.
2. Heartland Welding Academy will perform the R2T4 calculation and include as disbursed aid any existing Title IV credit balance funds for the period.
3. Heartland Welding Academy will apply any applicable refund policy (state, accrediting agency, and institutional) to determine if doing so creates a new or larger Title IV credit balance.
4. Any Title IV credit balance must be allocated first to repay any grant overpayment owed by the student as a result of the current withdrawal. Heartland Welding Academy will return such funds to the Title IV grant account within 14 days of the date the institution performs the R2T4 calculation.
5. Within 14 days of the date the R2T4 calculation was done, Heartland Welding Academy will pay any remaining Title IV credit balance funds in one of the following ways:
 - To pay authorized charges at the institution.
 - With student's written authorization to reduce the student's Title IV loan debt
 - To the student
 - If the student (or parent in case of a PLUS loan) to whom a Title IV credit balance must be paid cannot be located, Heartland Welding Academy will return the credit balance to the Title IV programs.

Heartland Welding Academy is required to make (or offer as appropriate) post-withdrawal disbursements. If the student is eligible for a post-withdrawal disbursement it must be made within 180 days of the date the institution determines that the student withdrew. The amount of any post withdrawal disbursement is determined by the R2T4 calculation. Post withdrawal disbursements must be made from available grant funds first, before loan funds. For loan funds, Heartland Welding Academy must notify a student (or parent in the case of a PLUS loan) in writing, prior to making any post-withdrawal disbursement.

This notification needs to be done within 30 days of the date of determination the student has withdrawn.

Heartland Welding Academy must notify a student, or parent for a Direct Parent PLUS Loan, in writing prior to making any post-withdrawal disbursement of loan funds, whether those loan funds are to be credited to the student's account or disbursed directly to the student (or parent). The information provided in this notification must include the information necessary for the student, or parent for a Direct Parent PLUS Loan, to make an informed decision as to whether the student or parent would like to accept any disbursement of loan funds and must be provided within 30 days of the date of HWA's determination that a student has withdrawn. In addition, the notice must request confirmation of any post-withdrawal disbursement that the student or parent, as applicable, wishes HWA to make.

G. Determination of Title IV Earned by the Student

Up through the 60% point in each payment period, a calculation is used to determine the amount of Title IV funds the student has earned at the time of withdrawal. After the 60% point in the payment period, a student has earned 100% of the Title IV funds.

Veterans and VA Students Refund Policy (GI Bill Recipients)

VA students attending this facility will be given a pro rata refund which is prorated on a daily basis. The exact portion will be determined on the ratio of the number of days of instruction completed by the veteran/VA student to the total number of instructional days in the course. In the event that the veteran/VA student fails to enter the course, the unused portion of the tuition, fees and other charges paid by the individual shall be refunded promptly, within 40 days. Registration fee above \$10 is subject to proration.

VA students will not be required to apply for this refund; it will be made when the school becomes aware of the individual's failure to enter the course, withdrawal or other discontinuance there from. If this institution ever applies a more favorable refund policy for the general student population it shall be applied to veterans/VA students as well.

Grievance Process

1. Students are encouraged to first discuss any grievances with their HWA Instructor.
2. Concern/Complaint Forms are made available for students to fill out. Complaints will be addressed in a timely matter by the Managing Director.
